Unlike any of the other



How To Protect Yourself From Imposter Scams

The phone rings and your Caller ID says it's the Bank. When you answer the phone, the caller says they are from the Fraud

Department. They tell you that your account has been compromised.

This is a very scary call to receive. The Bank does need to make these calls to our customers from time to time. Unfortunately, scammers will make these call to you as well as part of what are termed Imposter Scams. Imposter Scams are not new and have many variants - such as the Grandparent Scam, IRS Scam, or Romance/Online Dating Scam.

However, we have seen several cases lately of Bank Employee Imposter Scams affecting our customers. In these cases, someone will call saying they are from the Bank's Fraud Department (or possibly another area of the Bank). Your Caller ID may show a phone number with an out of state area

code. A more sophisticated scam will show the Bank's number as scammers often use a spoofing technique to make it look like they are calling from a legitimate phone number. These scammers may even use an actual Bank employee name when talking with you.

To add to the story, the scammer may be able to tell you your account numbers or balances. Frequently, these calls come after you clicked on a pop-up window on your computer saying you have a virus or other issue. The scammer uses this to gain access to your computer and possibly install a program that allow them to access your online banking information.

With the name, phone number, and account information, this may seem like a real call. However, one of the biggest red flags that this is a scam, is that they will say there is internal fraud at the Bank, and your account has been targeted.

They will tell you that in order to help find the person committing fraud, you will either need to wire money to an account outside the Bank (often to a foreign bank). The caller will give, or text you, the wire instructions. The scammer may alternatively ask you to

withdraw money and buy gift cards. Once purchased, they will ask you to call them back and provide gift card numbers and security codes. In both cases, they will tell you not to talk with anyone else at the Bank, since they don't know who is involved in compromising your account.

If the caller asks you to do any of this, Stop! The Bank will never contact you and advise you to send money somewhere or ask you to buy gift cards. We will also never tell you to not talk with others at the Bank.

The best thing to do is hang up and call the Bank's Customer Support number directly. This way you can be sure you are talking to legitimate Bank employees. They can help you confirm if your account has had any unusual transactions, or they will get you in contact with the actual Fraud Department. Do not call the number the scam call came from, as that will send you back to the scammer.

By taking the time to watch for these red flags, you can stop yourself from losing a significant amount of money, while keeping your accounts Safe and Secure.

Our group will meet outside of the
American Legion Post 245 and walk to the
Hickory Hill entrance at 9:00 a.m.

Reserve and Future National Park Service Ice
Age National Scenic Trail Interpretive Site on
Old Sauk Pass Road.

**Our hike will be approximately 3-miles
and will be a loop.**

Our hike will start at the end of Hickory
Hill Street, where a gate crosses an access

road that leads
north uphill into
the Hickory Hill
Conservation
Park. The hike
will enter a former
agricultural field
restored to native
prairie and the
IATA's Andersen
Preserve. This
segment soon
enters a woodland
that features not
only native flora
such as jack-
in-the-pulpit,
shooting stars

and wild ginger but also the glacial drainage
network known as "Three Gorges."

Our hike exits the forest and once more
crosses the former agricultural field and
oak savanna enjoying restoration and
gains elevation up the side of a dolomite
ridge. At the head of the ridge hikers will
find views to the south and east displaying
what conservationist Increase Lapham

described as the "Great Dividing Ridge."
On the distant ridge to the south, hikers
may see a lone majestic white pine, marking
the approximate location of the Cross
Plains National Scientific Reserve. The Blue
Mounds are also clearly visible to the west.
At this point the segment drops steeply 150
feet down a series of switchbacks to emerge
at Lewis Street between two houses.

If we were to carry on from here, the
segment continues on sidewalks and roads
through residential Cross Plains. We will
end our hike here and head back to the
American Legion where vehicles are parked.

Our hike will start at the Merrimac ferry south landing wayside at the ferry ramp near a large six-panel kiosk providing information on the Ice Age Trail. Yellow-blazed posts guide hikers through the grassy wayside area. The Trail then passes through a woods of white oak, shagbark hickory and maple before crossing busy STH-113 (we will cross with caution) near Northern Cross Arm Road.

of the hill. The Trail continues southeast through red cedar and existing remnant prairie areas with big bluestem, Indian grass, little bluestem and other native grass species. More scenic views of Lake Wisconsin and the surrounding landscape are offered from different points along the route. Our turn-around point will be the “big bench” that allows hikers a stunning panoramic vista of the Wisconsin River and Baraboo Hills.

After taking in the beautiful views and enjoying a snack break, we will turn around and head back to vehicles at the Merrimac ferry parking area.

We will not hike the Gibraltar Rock State Ice Age Trail Area on this hike. If attendees are interested in doing it on their own, directions can be provided.
